CE has met with one other person (Aimee) who may be interested and has another person who has emailed and will meet with them if they want to proceed.

Report from Administration -Administration Manager, Vicky Parkinson reported to Council:

- To accommodate continuing growth the Societies have relocated their offices to larger premises with lots of room to grow.
- A new administrator was employed in January 2013
- The CRM database is now working effectively and proving useful
- Admin has switched over to a new accountancy software package to replace Excel
- A 'captcha box' is now on both websites to stop spam mail.

Report from Memberships Services – CE Liz McElligott reported to Council

- Membership Services Manager Katie Spendiff has resigned from the Societies, appreciation of her services over the previous 12 months were expressed by CE
- Recruitment for a new membership services manager has been successful and a new person
 is due to join the Societies in May (with a week's induction initially). Anticipated that they
 will be introduces at the next Council meeting in July.

The minutes from the last Council meeting, on 1st April 2014 (circulated previously) were agreed by Council. Dr Phillip Rees (Independent Assessor) requested that his (2013) proposal about the Societies arranging clinic visits be reconsidered and agreed that this can be discussed when Dr Rees arranges his site visit of the Societies offices (date tbc).

Council welcomed new Society staff member, Freya Bottomley, and Lay Council member, Colin Irvine, and everyone gave a brief personal introduction and background information.

Proposal to Council						

Report from Professional Standards Committee, Chair Gerry Willmore:

- The PS Committee is in the process of recruiting a new member and anticipates confirming details by Autumn 2014 – will give further details at next Council meeting.
- Different organisations have approached the Societies since we achieved AVR status.
- Gerry has carried out site visits to training providers one for counselling and one for hypnotherapy
 Following full assessments training providers have had their courses accredited by the relevant
 Society.

- Awarding body AQA has withdrawn their counselling qualifications current courses will be honoured but programme wound down for future.
 Report from Society Administrator, CE Liz McElligott on behalf of Vicky Parkinson:
- Current membership figures were discussed and Liz explained to Council the difference between registrants and non-registrants

The Society staff have upgraded their computers and engaged a local IT support person

• All Society staff held a recent meeting to review current websites and share ideas for updates/changes

Report from Society CE, Liz McElligott:

- The Societies have successfully achieved the annual renewal of their AVR status for both registers.
- CE thanked Dr Rees on behalf of the Societies for the reports he produced to support the societies renewal application.
- Gerry paid tribute to Liz for the external relationships she has built on behalf of the Societies particularly
 with the PSA and other professional associations.
- Audits: constantly reviewing and further developing the Societies audit procedures.
 CE advised Council that the Societies have recruited a Deputy CE who will be involved with audits and the registers as part of her role.
- Conversion Therapy: the (draft) Memorandum of Understanding is now with the DH for their approval.
 Will circulate the final document to Council and asked for agreement in principle that Council approve the memorandum agreed by all.
- Further discussions amongst Council about the actual prevalence of so called 'conversion therapy' CE shared information from initial DH meeting and research done by Royal College of Psychiatrists.
- CE gave a summary of concerns / complaints that have been received by the Societies between 2013 and 2014 so far. Advised that the Societies will be reviewing their Complaints procedures and Eimear McAllister is assisting with this. The current 'Listening to Clients' policy was created in a joint project with the 'Clinic for Boundaries Studies' and has been in place since 2012 and we want to review and improve our policies and procedures.

CE introduced Rick Borges who is Accreditation Manager for the AVR scheme and everyone introduced

themselves – Rick had the opportunity to chat to individual Council members during lunch.

Lunch

AVR presentation from Rick Borges

- Rick informed Council that the PSA have existed since 2003 previously called the Council for Healthcare Regulatory Excellence (CHRE).
- A lot of international interest in AVR scheme. Rick is going to Hong Kong in September to talk about AVR scheme. There is also interest from Australia and Canada about the scheme.
- There are now 12 organisations holding AVR's under the PSA scheme
- Continuing to build links with NHS England and discussing different ways that AVR could be recognised in commissioning
- Dr Rees (who works within the NHS) commented that the AVR scheme is not known within the NHS on the ground- particularly within mental health services
- AVR are trying to raise profile in NHS and are going to be meeting with CCG's to let them know what the AVR scheme can offer
- Meeting planned with AVR's and Luther Pendragon to let them know what the AVR communication plans are and share ideas of how each organisation can spread the word
- Consulting with private health care insurers (including Bupa) how they could recognise and reimburse treatments from practitioners who are on AVR register.
- PSA Talking to Comic Relief to build recognition of the AVR scheme
- The scheme needs individual registrants to help disseminate information to the public about the AVR scheme
- Currently revamping AVR/PSA website to make information clearer for the public and easier to understand
- Question was raised as to who the PSA report to they report to Parliament, Health Select Committee although they are funded by the Department of Health.
- CE asked about the current fee structure in relation to affordability for smaller organisations. Rick said it was unlikely to change - although he did state that to help smaller organisations they have a cluster model which can be used and another option is for smaller organisations to ask the Department of Health to help fund them if needed.
- Currently awaiting applications from new organisations including some that are considered high profile by NHS England so this will in turn raise the overall profile of the scheme.
- Council thanked Rick for coming and for his talk

Other Business.

CE will be discussing current committees with Deputy CE - with the aim of her taking responsibility for these

Next Council meeting will be in November 2014 and CE suggested that when planning for next year's meetings will include a visit to the Societies' offices in Worthing.

The Minutes of the last Council Meeting on 28th July 2014 (circulated previously) were agreed by Council.


It was noted that some members had not received an invitation to write an introductory article for the Society newsletters. Gerry confirmed that this would still be welcomed.
